

## **BOARD OF TRUSTEES KEY MESSAGES**

Following are the Key Messages from the Board of Trustees Regular Meeting held on Monday, June 24, 2024. Each month the Board Key Messages are shared at School Council Meetings. See your school's website for information about upcoming meetings and agendas.

- 1) Early Learning Presentation Leanne Feller, Early Learning/Inclusive Learning Coach, provided the Board with an update of the work being accomplished throughout the division. Currently there are 2 Licensed Preschools and 1 Early Learning Centre within our division. Currently the Livingstone Range School Division Early Learning Programs have 37 students enrolled at A.B. Daley, 27 students enrolled at Canyon School and 52 students enrolled at Horace Allen school. Pre-kindergarten children continue to have access to Program Unit Funding (PUF). Currently the Livingstone Range School Division has 49 PUF students accessing educational support and the projection for the 2024-2025 school year is continuing to grow. The current 2023-24 kindergarten enrollment numbers throughout the division is 224. The Livingstone Range School Division will continue to have developmental check-ins and encourage more families to register in Early Learning. The first six years of a child's life is an amazing time in human development, when the brain is developing connections faster than at any other time in a person's life.
